UPON hearing the counsel the Court made the following
O R D E R

Perused the report dated 6th September, 2024 of the Medical Board of the Postgraduate Institute of Medical Education & Research, Chandigarh.

In view of what is stated in the aforesaid report, no case is made out for extending the temporary bail granted to the petitioner on medical ground. Accordingly, the Special Leave Petition is

disposed of.

The petitioner is directed to surrender within a period of one week from today.

However, considering the apprehension expressed by the learned senior counsel appearing for the petitioner, we direct that after every one month, the petitioner shall be examined by the same Medical Board of the Postgraduate Institute of Medical Education & Research, Chandigarh, with a view to ascertain the medical condition of the petitioner. Copies of the reports shall be provided to the petitioner.

We make it clear that the High Court has considered the prayer for bail only on the medical grounds and not on merits. If an application for grant of regular bail is made by the petitioner, the High Court will consider the same on its own merits.

Pending applications stand disposed of accordingly.
