1. Heard.
2. This MCC has been filed by the applicant seeking extension of time for the compliance order dated 12.08.2024 passed by this Court in Writ Petition (S) No.1159 of 2024.
3. The respondent Nos.1 to 43 filed a writ petition bearing WPS No.1159 of 2024 which was disposed of vide its order dated 12.08.2024 in which the Court made the following observation in para 5 which is as under:-

“From perusal of documents on record and the reply filed by respondent No.3, it is apparent that the main reason for withholding the recruitment process was that during that period, the model code of conduct was in force, since the model code of conduct is now lifted and respondent No.3 has also stated in their reply that they will conclude the recruitment process at the earliest, this Court is inclined to dispose of these writ petitions and it is expected that respondent No.3/Chhattisgarh State Minor Forest Produce (Trading and Development) shall conclude the recruitment process within a reasonable period of time preferably within a period of 90 days from the date of receipt of copy of this order.”

4. Learned counsel for the applicant submits that in compliance of the order passed by this Court, the recruitment process has already been initiated and is under progress. He submits that further 90 days time may be granted to conclude the same.

5. Mr. Acharya submits though he is not opposing the extension of further time to comply the order, however, instead of 90 days' time 60 days may be granted to comply the same.
6. Be that as it may, considering the facts and circumstances of the case and the submissions made by the parties at bar, this Court is inclined to grant further 90 days time to complete the recruitment process as directed by this Court in Writ Petition (S) No.1159 of 2024 from today.
