This second application for anticipatory bail has been filed under Section 482 B.N.S.S. (previously 438 Cr.P.C.) by the petitioner apprehending his arrest in connection with F.I.R. No.0210/2019 registered at Police Station Narayanpur, District Alwar for the offence(s) under Section(s) 420 & 406 of IPC and later on for the offences under Section(s) 419, 420, 464, 465, 466, 467, 468, 469, 470, 471, 472, 473, 474, 475, 476, 409 & 120-B IPC.

It is contended by learned counsel for the petitioner that he has falsely been implicated in this case and pursuant to direction of this Court dated 12.12.2024, he has joined the investigation. He submitted that there is no incriminating evidence against the petitioner, his custodial interrogation is not warranted and prayed for his release on pre-arrest bail.

Although, learned Public Prosecutor opposed the prayer; but, could not dispute that pursuant to direction of this Court dated 12.12.2024, the petitioner has joined the investigation, he has

been interrogated and there is no incriminating evidence available on record to reflect his criminal conspiracy.

Taking into consideration the contentions advanced by the learned counsels for the respective parties especially, that of learned Public Prosecutor; but, without expressing any opinion on the merits of the case, this Court deems it just and proper to enlarge the petitioner on anticipatory bail under Section 482 B.N.S.S. (438 Cr.P.C.).

Accordingly, the second bail application is allowed and it is directed that in the event of arrest of petitioner in connection with afore-mentioned FIR registered at concerned Police Station the petitioner **Rajsingh Chouhan S/o Late Ashok Singh** shall be released on bail; provided he furnishes a personal bond in the sum of ₹1,00,000/- (Rupees One Lac only) together with two sureties in the sum of ₹50,000/- (Rupees Fifty Thousand only) each to the satisfaction of the concerned Investigating Officer/S.H.O. on the following conditions :-

- (i). that the petitioner shall make himself available for interrogation by a police officer as and when required;
- (ii). that the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court or any police officer; and
- (iii). that the petitioner shall not leave India without prior permission of the court.
