The petitioner contested for the item 'Ottanthullal' (Girls) in the Revenue District School Kalolsavam, Thiruvananthapuram. The petitioner, though, performed well could secure only the 2<sup>nd</sup> position. Several grounds are seen urged in this writ petition. However, the learned counsel would refer only to Ext.P3 order of the appeal committee, wherein the performance of the petitioner was also found to be excellent. The ability of the candidate was also specifically mentioned. However, the appeal was dismissed for the reason of paucity of the time and number of the contestants.

2. The learned Government Pleader has seriously opposed and submitted that, there is nothing to indicate that the Code No.273 pertains to petitioner.
