# <u>JUDGMENT</u>

The original petition challenges Ext.P6 order, an order passed by the Debts Recovery Tribunal-2, Ernakulam, in I.A.No.1966/2023 and I.A.No.1967/2023, appointing an Advocate Commissioner to take custody of 'B' schedule vehicle of the petitioner and to place it in the interim custody of the bank until further orders of the Tribunal.

2. Upon admission of the original petition, an interim order was passed by this court on 07.07.2023, staying the operation of Ext.P6 to the extent it permitted the Advocate Commissioner to take custody of the 'B' schedule vehicle. The said order of this court was challenged in SLP (C)No.20387/2023, which by order dated 15.07.2024 was varied as follows:

"We are informed that O.P.(DRT) No.254 of 2023 is still pending before the High Court.

In the facts and circumstances of the present case, we permit Advocate Commissioner to proceed in accordance with law. The impugned order is varied to this extent.

Recording the aforesaid, the special leave petition is disposed of. However, all rights and contentions of the parties are left open."

- 3. Learned Standing Counsel for the bank submits that the petitioner herein had surrendered the vehicle and the bank had sold the same. This is recorded. It is submitted by the learned Counsel appearing on both sides that the O.A. is still pending consideration.
- 4. Given the above order of the Supreme Court and the subsequent event of surrender of the vehicle in question, nothing further remains to be considered in this original petition, and the same is disposed of, leaving open all the contentions of the parties to be agitated before the Tribunal.

The original petition is disposed of accordingly.
