



THIS WRIT PETITION (CIVIL) HAVING BEEN FINALLY HEARD ON 09.06.2025, THE COURT ON 12.06.2025 DELIVERED THE FOLLOWING:

JUDGMENT

The petitioner states that she is engaged in the welfare and stray and community dogs. The petitioner has set up a community dog shelter to provide care for several stray dogs. The petitioner has ensured vaccination, sterilisation and proper medical treatment to the stray dogs, in compliance with the Prevention of Cruelty to Animals Act, 1960 and the guidelines of the Animal Welfare Board of India.

2. The petitioner states that respondents 4 to 7 are threatening the petitioner since February, 2025, opposing the conducting of community dog shelter. Respondents 4 to 7 and persons claiming under them trespassed into the dog

shelter of the petitioner and threatened the petitioner and her employees and volunteers. The petitioner and others were abused in filthy language. The compound fencing was damaged.

- 3. Apprehending danger, the petitioner 2nd submitted Exts.P1 and P3 petitions before the respondent-Deputy Superintendent of Police and the 3rd respondent-Station House Officer requesting adequate and sufficient police protection to the life and property of the petitioner and her employees/volunteers in the community dog shelter. The respondents have not given sufficient protection to the petitioner.
- 4. During the pendency of the writ petition, the petitioner filed an affidavit dated 06.06.2025 in which it is alleged that on the late hours on 03.06.2025, several persons under the leadership of respondents 4 to 7 trespassed into the house and brutally attacked the petitioner. They demolished compound wall and fencing. Household articles

were also damaged. The petitioner sustained incised wound on head. The police who came to the spot remained as mute spectators.

- 5. The petitioner stated that Article 51A(g) of the Constitution of India states that it is duty of every citizen to protect and improve the natural environment including forests, lakes, rivers and wildlife and to have compassion for all living creatures. The petitioner is a law abiding citizen and is carrying out fundamental duties envisaged by the Constitution of India.
- 6. The petitioner has ensured vaccination, sterilisation and proper medical treatment to the dogs, in compliance with the Prevention of Cruelty to Animals Act, 1960 and the guidelines framed by the Animal Welfare Board of India. Due to the threats, intimidation and possibility of physical harm, the petitioner is unable to freely carry on the lawful and charitable activity. There is imminent threat to the petitioner, her volunteers and the dogs.

- 7. Respondents 4 and 5 resisted the writ petition filing counter affidavit. The petitioner took on rent a house from the 6th respondent's father. The petitioner represented that she possesses two or three pet dogs which are also to be accommodated in the rented house. To the surprise and predicament of respondents 4 to 6, the petitioner brought as many as 65 stray dogs to the rented residential house.
- 8. The petitioner is not residing in the said house. Stray dogs are let loose in the residential compound. The stray dogs frequently fight, bark and defecate in the compound, in the verandah and rooms in the house. Food waste collected from somewhere is given as feed to the dogs. The compound is not being cleaned, nor the house. The balance food waste and excreta cause stench around the area. The conditions in the dog shelter and the neighbourhood is extremely unhygienic.





- 9. The 4th respondent is residing less than 25 metres away from the compound. Local citizens preferred complaint before the Grama Panchayat and local police. The complaints were of no avail. The Revenue Divisional Officer conducted an enquiry and found that the grievance of the local people is genuine. The RDO therefore issued Ext.R5(e) order dated 09.04.2025 directing the petitioner to shift the dogs. Ext.R5(h) report submitted by the Health Inspector stated that the petitioner is rearing 42 number of dogs and that the foul smell from its waste and collective barking, make the life of the local people miserable.
- affidavit in similar lines. The petitioner is running a dog shelter without necessary approvals or clearances from the Panchayat. The dog shelter is unauthorised. When legitimate concerns are raised by the people of the locality including health and sanitation issues, the authorities are bound to consider them and act accordingly.

- 11. I have heard the learned counsel for the petitioner, the learned Government Pleader representing respondents 1 to 3 and the respective learned counsel appearing for respondents 4 to 7.
- 12. The petitioner is admittedly running a community dog shelter in a rented premises. The petitioner would urge that she is discharging her duties in tune with Article 51A(g) of the Constitution of India. The inspections made by statutory authorities would indicate that the petitioner is rearing 48 to 65 stray dogs. There is no scientific arrangement for feeding the dogs. It has come out through pleadings that food waste spread in the compound and the excreta shed by the dogs causes stench in and around the area. The Health Inspector has reported that the collective barking of the dogs creates sound pollution, making life miserable for the local population.
- 13. The petitioner has not obtained any permission or licence to run the dog shelter. In a similar

case, in the judgment in *Irshad T.M. v. State of Kerala* [2024 (2) KLT 248], this Court held that to run a stray dog shelter, the petitioner should approach the Local Self Government Institution for getting licence for keeping the stray dogs in a premises. It is submitted that all the stray dogs have been temporarily shifted from the premises in question now. That being the position, there is no cause for concern as of now.

The writ petition is therefore disposed of making it clear that if the petitioner wants to continue to run the shelter home for dogs, she shall do so only after obtaining necessary sanction from the statutory authorities. In such an event, if the petitioner still faces any threat, the petitioner will be free to approach respondents 2 and 3 with appropriate complaints.
