ORAL ORDER

Learned counsel for the petitioner prays for time to take steps against respondent No.5(a to d), respondent Nos. 8 and 10. The petition is posted for the third time and the order sheet discloses that, emergent notice was issued to respondent Nos. 3 to 10 on 06.11.2023.



The order sheet dated 24.07.2025 in WP No.36294/2019 reads as under:

" 1. *None appears for the petitioner.*

2. *A week's time is finally granted for the petitioner to make payment for necessary process fee in respect of the unserved respondents and the proposed respondent No.5(a to d).*

3. *If needful is done by 04.08.2025, registry is directed to issue notice returnable by 09.10.2025.*

4. *If needful is not done by 04.08.2025, list this matter on 14.08.2025 for dismissal."*

Inspite of that, no steps are taken till date. Under such circumstances, I do not find any reason to adjourn the matter. Hence, the petition is ***dismissed for default i.e., for non-prosecution.***
